

In this regard the above school building was re-inspected by me on 28-11-2025 and submitted the report & recommended to issue Renewal Fire Safety Compliance Report.

Under the above circumstance the Karnataka State Fire & Emergency Services Department is issuing the "Renewal Fire Safety Compliance Report M/s. Golden Educational and Social Charitable Trust's situated at M/s. Golden International School (CBSE Syllabus), Bagur Sonnenahalli, Chikkathirupathi Post, Malur Taluk, Kolar District-563 160 subject to proper maintenance of firefighting installations in the good working conditions and arrange for 40% of staffs/employees training within 03 months from the date of issue of this report.

In case the Fire prevention and Fire Fighting measures installed as per the recommendation of the department are not maintained in good working condition, if the evacuation measures are not properly followed and if any additional construction work is taken up in the building/premises, the Fire Safety Compliance Report deemed to be cancelled and necessary legal action will be initiated against the developer/management/tenant and also separate NOC has to be obtained from the department for the storage of chemicals, solvents, petroleum products(Diesel/Petrol), LPG, etc. in the premises/building.

"This Report is Valid up to 22-02-2028 and should be renewed without fail before the validity period".
