



5. Powers and Duties of the Office Bearers:

11. Financial Year:

The Trust shall follow the financial year from April to March of the succeeding year.

12. Bankers and Bank Accounts:

All funds collected by the Trust shall be kept in a bank in the joint names of President, Secretary and Treasurer and shall be operated by any two of them. The Trust shall have a savings and a current account.
